1. The 4th International Symposium of the AACC SRD

From 29 May to 1 June 2023, the AACC SRD successfully held its 4th International Symposium. As the pandemic has ended, this was the first in-person conference held by the AACC SRD since 2019. Just as in previous years, this conference was closely linked to the AACC SRD's annual book project, sharing the same title: "Access to Justice: Constitutional Perspectives". In addition to AACC members, special guest institutions were also present at this Justice-level event. These were the Constitutional Court of Algeria and the Supreme Court of New Zealand.



The Symposium was structured via three main sessions: 1) *individual access to constitutional justice*, 2) *current issues on access to justice*, and 3) *constitutional rights ensuring access to justice*. These were followed by a concluding General Session, where the chairs of the above three sessions were invited to sum up the discussions from their respective sessions and provide additional perspectives. Thanks to the valuable contributions by AACC members and the two guest institutions, the event proved to be a fruitful exchange of information and insights on the AACC SRD's 2023 research topic. The planned book on "Access to Justice: Constitutional Perspectives" will be published in December 2023. In the second half of this year, the AACC SRD looks forward to working with AACC members during the book's editing process.

2. Appointment of new Deputy Secretary Generals



3. New financial support opportunity for secondment

The AACC SRD's secondment program has been operating in accordance with the mandate of the amended Article 22 of the AACC Statute, as agreed by AACC members at the Board of Members Meeting in August 2016. Therefore, every AACC member is entitled to send seconded officers to the AACC SRD.

According to Elaboration 3.7. of the amended Article 22 of the AACC Statute, the home institutions of seconded officers will be entirely responsible for the costs of secondment.

Recognizing the value and expertise that seconded officers

bring, the AACC SRD has been actively exploring external financial support opportunities, including private sponsorships, to connect with seconded officers who are interested in joining research activities at the AACC SRD in Seoul.

We are pleased to announce that the AACC SRD has succesfully secured external funding support by signing a MOU with the HONGJINGI Legal Research Foundation in Korea in July 2023. This funding will provide support for living costs (1,000,000 Korean won per month) and one round-trip economy flight ticket for one seconded officer during the period of one year. By providing some financial support, it can offer our seconded officers a certain degree of financial assistance, although it may only cover living costs to a limited extent in Seoul.
